RECITALS

- A. A Declaration of Covenants, Conditions, Restrictions, Easements and Reservations ("Declaration") was previously filed and recorded under King County Recording No. 9904082528 upon the real property more particularly described in the declaration. The Declaration was subsequently amended on October 6, 2015 under King County Recording no. 20151006000346.
- B. It is desired to amend Section 3.2.1 of the Declaration in order to clarify costs and review fees related to the submission of plans to the Architectural Control Committee.

1. Amendment. Section 3.2.1 shall be removed and replaced with the following:

Submission of Plans and Plan Review Fee. Before commencing Construction of any Structure on any Lot, the Owner shall submit to the Architectural Control Committee two (2) complete sets of detailed building (including, but

not limited to, proposed paint color and roofing materials), construction, surface water-run-off and landscaping plans and specifications, and a site plan showing the topography and location of all proposed Structures (the plans, specifications and site plans are collectively referred to herein as the "Plans"). Should the ACC incur expenses to review the plan (including but not limited to costs related to legal review of submissions, environmental impact assessments of changes on common areas or adjacent properties, for example) the ACC will charge the submitter the actual costs of review incurred. If fees are estimated to exceed \$500, the ACC will notify the submitter of the estimated fee. The ACC will invoice the submitter for any required Plan Review Fees. Approval of the submission will not be granted until that invoice is paid, in the form of a check made payable to the Association.
